Cognitive Linguistic Approaches to Teaching Vocabulary and Phraseology-Frank Boers 2008 Mastering the vocabulary of a foreign language is one of the most daunting tasks that language learners face. The immensity of the task is underscored by the realisation that it is not only single words but also numerous standardised phrases (idioms, collocations, etc.) that need to be acquired.
